2020-2021 Guidelines

Scholarship Eligibility

- 1. The applicant must be/or become a member of ēCO Credit Union, with their account in good standing. Applicant must become a member no later than March 13, 2020.
- 2. The applicant must be a senior in high school who will be enrolled or plan to be enrolled in an undergraduate course of study during the 2020-2021 academic school year at an accredited 2- or 4- year college, university, or vocation-technical college in the United States.
- 3. Members of the ēCO Board of Directors and the Scholarship Committee and their immediate family members/dependents of the same household are not eligible to receive scholarship. ēCO employees and their family members/dependents of the same household are not eligible for scholarship.

Application

- 1. Scholarship applications and accompanying documentation must be completed in full and returned to the credit union by the submission deadline of March 13, 2020 to be considered for scholarship.
- 2. Please type or neatly print applications in black or blue ink.
- 3. All information provided to ēCO Credit Union with the scholarship application will remain confidential. No materials will be returned.

Selection

- 1. Applications will be reviewed by the ēCO Scholarship Committee.
- 2. Finalists may be asked to meet with the Scholarship Committee for an informal interview.
- 3. Recipients of the Scholarship will be notified no later than April 10th and are expected to attend the Scholarship Awards Luncheon, scheduled for May 8th.
- 4. All decisions concerning the scholarship award will be the responsibility of the Scholarship Committee, and all decisions of the Scholarship Committee are final.

Payment

- 1. Scholarship checks will be paid directly to the institution of the recipient's designation no later than August 31, 2020.
- 2. Recipients of scholarship must provide ēCO with proof of enrollment at the intended school named on application. Such proof would be a course schedule, receipt from registrar's office, etc.
- 3. ēCO Scholarships are non-recurring awards.
