



## 2021 ALET Debbie Rice Memorial Scholarship

The Alabama Leaders in Educational Technology (ALET) organization invites graduating seniors to apply for its \$10,000 2021 ALET Debbie Rice Memorial Scholarship. Applicants who meet the criteria below should read the guidelines carefully and follow the directions for submission. All applications must be received by mail and must be postmarked by November 18, 2020.

### **Criteria for Scholarship Applicant:**

- The student must be a high school senior who is currently enrolled in an accredited Alabama high school.
- The technology director of the school system where the student is enrolled must be a current member of ALET as of October 1, 2020. A list of eligible systems is included for your reference.
- The applicant must have a minimum Cumulative GPA of 2.75 or higher, using a 4.0 scale-unweighted.
- The applicant must have an ACT score of 17 or higher.
- Applicants must have the endorsement/signature of their Guidance Counselor/Principal on their application attesting they are qualified to apply for this scholarship.
- The student must plan to attend an accredited college, university, or technical school physically located in the state of Alabama. Full-time online colleges do not qualify.
- The student should demonstrate an interest in pursuing a degree in Computer Science, Information Technology, or a technology-related field.
- The student should be able to demonstrate a history of volunteering and be active in school or non-school extracurricular activities.

### **How to Apply:**

- Review the checklist of required materials in order to ensure that your application will be complete. Prepare all the necessary forms and documents and complete the checklist.
- All application packets must be mailed via U.S. Post Office, or other carrier to ALET and must be postmarked on or before November 18, 2020.
- Unless otherwise indicated, all required materials, including letters of reference, must be in the submitted packet. The only exception is School Transcripts. The school may either email or mail the student's transcript separately but must do so by the November 18, 2020 deadline.
- Incomplete packets will not be considered. Applicants may not add materials to the packet once it is received. (Exception: The transcripts may be sent by the school after the application packet is received provided they are emailed or postmarked by November 18, 2020).

### What to Include in your Scholarship Application Packet:

- Application form, completed in full
- Signed Statement of Accuracy and Conditions
- Resume - See specific requirements in Checklist
- Essay - See specific requirements in Checklist
- Two letters of recommendation as to your character and your ability to meet your scholastic and community responsibilities.
  - Both letters must be signed by the author and must also include their printed name, phone number, mailing address, and email address.
  - One letter must be from the principal and/or counselor of the student's high school.
  - Letters may **not** be sent by email.
- Transcript from your high school
  - Transcripts must come from the student's school, but do not need to be official.
  - Transcripts may be included in the packet or be emailed directly from the school.
  - Transcripts must be emailed or postmarked by the deadline of November 18, 2020.
- Report Card from 1st grading period of this school year (copy is acceptable)
- ACT score report if it is not listed on school transcript
- Checklist page

### Confirmation of Receipt:

### Incomplete Application Packages:

It is the applicant's responsibility to make sure the application is complete and arrives on time. **Incomplete applications will not be considered.**

### Review Committee:

The applications will be reviewed, and the recipient of the scholarship will be selected by a committee of volunteers. *Following directions is important. For example, points may be deducted if you respond to the essay questions in the wrong order.*

### Important Dates:

- Application and Transcript Deadline: November 18, 2020.
- Notification of Winner: January 2021
- Recipient may be invited to attend an ALET event where the scholarship will be presented.

This \$10,000 scholarship is contingent upon your acceptance and attendance at an Alabama college or university. If you should decide to attend a college outside of Alabama, you must notify us immediately as we would need to rescind the offer. ALET will release only as much of the award as is needed to pay your college costs. For instance, if you receive another scholarship and the two scholarships combined would exceed your needs for your freshman year, then we will defer the balance until your second year of school. The full amount should be expended within two academic years of the award. Any remaining balance will revert to ALET.
